WHEREAS, The Local Government Unit assure that the rights of the children is given priority to exercise their rights giving importance on Education, Health and Nutrition;


WHEREAS, the utilization and allocation of the aforesaid Fund and Plan needs the ratification and approval of the Sangguniang Bayan;


