**AN ORDINANCE AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 2 SERIES OF 2022 INVOLVING AN AMOUNT OF TWO MILLION NINE HUNDRED FIFTY FIVE THOUSAND (P2,955,000.00) PESOS FOR THE MAINTENANCE AND OTHER OPERATING EXPENSES, CAPITAL OUTLAY OF DIFFERENT OFFICES PROJECTS OF THE MUNICIPALITY OF ALAMINOS, LAGUNA**

*Be it ordained in Regular Session assembled:*

**SECTION 1.** *The Supplemental Budget of the Municipal Government of Alaminos, Laguna for the fiscal Year 2022 in the total amount of Two Million Nine Hundred Fifty Five Thousand (P2,955,000.00) Pesos for the maintenance and Other Operating Expenses, capital Outlay of different Offices projects of the Municipality of Alaminos , Laguna.*




**SECTION 4 EFFECTIVITY**. The provisions of the ORDINANCE shall take effect on November 28, 2022
