RESOLUTION REQUESTING FOR CASH ASSISTANCE OF ONE HUNDRED THOUSAND (PH100,000.00)PESOS FOR THE RURAL HEALTH UNIT WORKERS (RHU), BARANGAY HEALTH WORKERS (BHWs) AND BARANGAY NUTRITION SCHOLARS (BNS) OF THE MUNICIPALITY OF ALAMINOS FROM THE TGP PARTYLIST THROUGH HON. JOSE "TEVES, JR.

WHEREAS, it is the policy of the State to protect and promote the right to health of the people through improved delivery and availability of primary health services across the nation. It is also the policy of the State to promote employment opportunities in all sectors of society, including the health sector and the health personnel who form part thereof, Towards this end, the State created health care units at the local level to ensure the delivery of healthcare services;

WHEREAS, the Rural Health Unit (RHU) was created to provide prevent, regulatory, and medical care services in the local government units nationwide. The Barangay Health Workers (BHW) and Barangay Nutrition Scholars (BNS) likewise serve as qualified health care providers who provide primary health care services and monitor the nutritional status of children in the community based on the guidelines given by the Department of Health (DOH);

WHEREAS, the RHU, BHWs, and BNS continue to render frontline services in the administration of vaccines and other medical services in the Municipality. In view of this, the RHU, BHWs and BNS are highly exposed to the risk of contracting Covid-19;

WHEREAS, the Sangguniang Bayan deems it necessary to request for cash assistance in favour of the RHU,BHWs and BNS;

NOW THEREFORE, be it resolved as it is hereby resolved, that the Sangguniang Bayan is requesting the TGP Partylist, through Hon. Jose "Bong" Teves, Jr. for cash assistance in the amount of one hundred thousand pesos (Php 100,000.00) in favour of the Rural Health Unit workers (RHU), Barangay Health Workers (BHW), and Barangay Nutrition Scholars (BNS);
