A RESOLUTION APPROVING MDRRM PUBLIC SERVICE CONTINUTTY PLAN 2021-2025.

WHEREAS, The Local Government Code of 1991 mandates all Local Government Units (LGUs) to be frontline of emergency measures during and after disasters. Further, the enactment of Republic Act 10121 strengthened the capacities of LGUs through the promotion of bottoms-up and participatory approach in disaster risk reduction and management (DRRM);

WHEREAS, Section 2 of RA 10121 declares that it is the policy of the State to recognize and strengthen the capacities of LGUs and communities in mitigating and preparing for responding to, and recovering from the impact of disasters;


WHEREAS, as commitment to Sendai framework for Disaster Risk Reduction (SFDRR) 2015-2031 P. 33, Priority 4 government agencies must ensure the continuity of operations and planning including social and economic recovery, and the provision of basic services in the post disaster phase,

WHEREAS, Pursuant to the Office of the President of the Philippine Cabinet Action Decision File No. 381-120517-34 all government agencies should have their respective Public Service Continuity Plan (PSCP) to guarantee the continuity of operations amidst descriptions,


WHEREAS, Pursuant to NDRRMC No. 57 S. 2018, providing template for the PSCP for government agencies,
