RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF SAMAHAN NG IKATLONG LAHI (SILA) IN THE MUNICIPALITY OF ALAMINOS, LAGUNA.

WHEREAS, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and 'non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, on June 15, 2022, the Department of the Interior and Local Government issued Memorandum Circular No.083, Series of 2022, on the guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives on the Local Special Bodies;

WHEREAS, the Samahan ng Ikatlong Lahi (SILA), through its President/Executive Director or equivalent, has signified its intention to be accredited CSO in the Municipality of Alaminos, Laguna to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

WHEREAS, the Samahan ng Ikatlong Lahi (SILA) has satisfactorily complied with the requirements and criteria for accreditation as a civil society organization in accordance with the procedures and guidelines set forth in DILG MC No.083, Series of 2022;

WHEREFORE, on motion of Hon. Jacklyn A. Villanueva and duly seconded by All Members Present, be it;

RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Bayan to approve and grant the accreditation of Samahan ng Ikatlong Lahi (SILA) in the Municipality of Alaminos;
