WHEREFORE, on motion of Hon. Jacklyn A. Villanueva and duly seconded by All Members Present, be it;



RESOLVED FURTHER, that this accreditation is effective only until June 30,2025;



Adopted this 5th day of September, 2022 in the Municipality of Alaminos, Laguna.


