RESOLUTION NO. 155

A RESOLUTION RE-ORGANIZING THE COMPOSITION OF THE MUNICIPAL PROJECT MONITORING COMMITTEE (MPMC) OF THE MUNICIPALITY OF ALAMINOS, LAGUNA.

WHEREAS, Executive Order No.376, Series of 1989, mandates the establishment of the Regional Project Monitoring and Evaluation System (RPMES) and setting thereto its objectives, scope and coverage and the formulation of manual of operations in order to facilitate project implementation, problem solving, monitoring and evaluation of foreign, national and locally funded projects at sub- national levels;

WHEREAS, pursuant to aforesaid executive issuance, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2004-78 dated June 22, 2004 on the Organization/Reactivation of Projects Monitoring Committee (PMCs) in the Local Government Units;

WHEREAS, the Municipal Government of Alaminos has created the MPMC under Executive Order No. 17, Series 2017;

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 1019-188 dated November 4, 2019 to enjoin local government officials to organize local PMCs in their respective areas of jurisdiction if not yet established or reconstitute said LPMCs if already existing and inform the LPMCs of their functions and responsibilities;

WHEREAS, there is an urgent need to institutionalize a comprehensive and decentralized project and monitoring system with the kind of timelines that is necessary in order to take a quick action on problems that are encountered in the implementation of projects in the Municipality of Alaminos, Laguna;

WHEREAS, there is need to re-organize the composition of the MPMC in Alaminos, Laguna in order to strengthen its composition, its duties and responsibilities herein follows to wit;




