WHEREAS, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, on June 15, 2022, the Department of the Interior and Local Government issued Memorandum Circular No.083, Series of 2022, on the guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives on the Local Special Bodies;

WHEREAS, the Samahan ng Kababaihan ng Brgy. San Benito - STK, through its (President/Executive Director or equivalent), has signified its intention to be accredited CSO in the Municipality of Alaminos, Laguna to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;
