## RESOLUTION NO. 174-A Series of 2022

A RESOLUTION APPROVING THE UTILIZATION OF TWENTY PERCENT (20%) DEVELOPMENT FUND OF ALAMINOS, LAGUNA FOR THE BUDGET YEAR 2023 IN THE AMOUNT OF THIRTY FIVE MILLION (35,000,000.00) PESOS.

WHEREAS, section of the IRR of R.A. No 7160 known as the Local Government Code of 1991 mandates the preparation and approval of Annual Investment Program during fiscal year before the calendar for the budget preparation;

WHEREAS, R.A. 7160 mandates each and every Local Government Units (LGU) to appropriate at least 20% of the IRA for development projects consistent with the principles and devolution and local autonomy;

WHEREAS, the MDC identified the priority projects embodied in the Comprehensive Development Plan 2020-2025 that can be funded by the twenty Percent (20%) Development Fund CY 2023 of Alaminos, Laguna;

WHEREAS, after deliberation, the MDC agreed that the Twenty Percent (20%) Development Fund CY 2023 of the Municipality of Alaminos shall be
