**A RESOLUTION EXTENDING THE DEADLINE SET FOR THE FILING AND
PAYMENT OF BUSINESS AND MAYOR'S PERMIT IN THE MUNICIPALITY OF
ALAMINOS FROM JANUARY 20 TO MARCH 30, 2022.**

WHEREAS, Art, B Sec 2B.01 of the Revised Tax Revenue Code 2016 of Alaminos, Laguna provides that " The tax imposed herein shall accrue on the first day of January of each year as regards subject then liable thereto be paid within the first 20 days of January and the same may be paid in quarterly installment payments and in each subsequent quarter;

WHEREAS, under the abovementioned Article B of the Revised Tax Revenue Code, states that " The Sangguniang Bayan, however, thru a resolution may extend the time of payment of such tax without penalty or surcharge for a justifiable reason or cause, provided, that the period of extensions shall not exceed six (6) months;

WHEREAS, in response to mitigate the economic impact in the local business caused by the pandemic, the Local Chief Executive requested this august body for a resolution extending the deadline set on the filing of Mayor's Permit for businesses for CY2022 in order to give taxpayers sufficient time to settle their obligation with the local government;


WHEREAS, an extension granted in the filing of Business and Mayor's Permit to the local taxpayers is a response and support of the Local Government of Alaminos to the financial recovery of the businesses from the adverse effect brought about by the COVID- 19 pandemic ;

WHEREAS, the Municipality of Alaminos ensures its compliance of RA11032 or the Ease of Doing Business and Efficient Government Service Delivery Act and aims to provide a legal instrument that gives effect to a government policy intervention more specifically on granting Business Permits and Licenses;




