A RESOLUTION APPROVING THE UPDATED MDRRMC CONTINGENCY PLAN 2023- 2025.

WHEREAS, The Local Government Code of 1991 mandates all Local Government Units (LGUs) to be frontline of emergency measures during and after disasters. Further, the enactment of Republic Act 10121 strengthened the capacities of LGUSs through the promotion of bottoms-up and participatory approach in disaster risk reduction and management (DRRM);

WHEREAS, Section 2 of Republic Act 10121, states that the local government units shall uphold the people's constitution rights to life and property by addressing the root causes of vulnerabilities to disaster, strengthening the country's institutional capacity for disaster risk reduction and management and building the resilience of local communities to disasters including climate change impacts;


WHEREAS, R.A 10121, defines Contingency Planning as a management process that analyzes specific potential events of emerging situations that might threaten society or the environment and established arrangements in advance to enable timely, effective and appropriate responses to such events and situations;

WHEREAS, Section 4 of RA 10121, mandates the municipal DRRMOs or BDRRMCs, in coordination with concerned national agencies and instrumentalities, shall facilitate and support risk assessments and contingency planning activities at the local level;

NOW, THEREFORE, upon motion of Coun Jeyson C. Abu and duly seconded by Hon. Jacklyn A. Villanueva and Approved by All Members of the Body Present, **RESOLVED AS IT IS** hereby Resolved to ratify the Updated MDRRMC Contingency plan 2023-2025 be ratified.


