A RESOLUTION APPROVING THE REALIGNMENT OF 20% DEVELOPMENT FUND FROM THE UNIMPLEMENTED PROJECTS OF 2022 AND CONTINUING APPROPRIATIONS FROM THE PREVIOUS YEARS AMOUNTING TO THIRTY-SEVEN MILLION NINE HUNDRED SEVENTY FIVE THOUSAND EIGHT HUNDRED SIXTY PESOS AND SEVENTY FIVE (P 37,975,860.75)CENTAVOS.

WHEREAS, the Honorable Mayor who is the Chairman of the MDC informed the Municipal Development Council members the need to realign the funds for unimplemented projects due to implementation issues under the 20% Development Fund 2022 and previous years into other readily implemented priority projects embodied in the Comprehensive Development Plan;

WHEREAS, The status of all projects under the 20% Development Fund were reported to the council during the meeting, and the issues on project implementation were deliberated;

WHEREAS, the MDC agreed to recommend for the realignment of the funds for unimplemented projects under the 20% Development Fund 2022 and previous years amounting to Thirty-Seven Million Nine Hundred Seventy-Five Thousand Eight Hundred Sixty Pesos and Seventy-Five (P37,975,860.75)centavos to wit;




