A SANGGUNIANG BAYAN RESOLUTION FOR THE REPAIR/RENOVATION OF PRESENT RURAL HEALTH UNIT FACILITY OF THE MUNICIPALITY OF ALAMINOS, LAGUNA THRU THE DEPARTMENT OF HEALTH (DOH) HEALTH FACILITY ENHANCEMENT PROGRAM (HFEP) FOR 2022 TO COMPLY WITH THE DOH/PHILHEALTH STANDARD IN PREPARATION FOR DOH/PHILHEALTH ACCREDITED FACILITY.

WHEREAS, the DOH Health Facilities Enhancement Program (HFEP) serving as the national government's major strategy to provide assistance to government-owned healthcare facilities for improvement of infrastructure for improvement of infrastructure, equipment upgrades, medical transport such as mobile dental vans and ambulances, and acquisition of land for health facility expansion.

WHEREAS, The Health Facilities Enhancement Program (HFEP) of the Department of Health (DOH) aims to improve public health facilities by constructing new and upgrading and rehabilitating existing public health facilities across the country such as barangay health stations, rural health units/urban health centers and Local Government Unit hospitals. The program assists in enabling government health facilities in providing affordable quality care and specialized treatments.

WHEREAS, the Department of Health thru the Health Facilities Enhancement Program (HFEP) for calendar year 2022 has allocated the amount of Six Million Five Hundred Thousand Pesos (P6,500,000.00) intended for the repair/renovation of Rural Health Unit Facility of the

Municipality of Alaminos, Laguna to be implemented by the Local Government of this municipality.


WHEREAS, the said repair/renovation of the present Rural Health Unit Facility is to comply with the DOH/PhilHealth Standard and in preparation for DOH/PhilHealth Accredited Facility.

NOW THEREFORE, upon motion of Honorable Morris Albert S. Matibag duly seconded by Honorable Rammel E. Banzuela, be it RESOLVED as it is hereby RESOLVED the repair/renovation of present Rural Health Unit Facility of the Municipality of Alaminos, Laguna thru the DOH-HFEP for 2022 to comply with the DOH/PhilHealth Standard in preparation for DOH/PhilHealth Accredited Facility be approved.
