RESOLUTION APPROVING EXECUTIVE ORDER NO. 21 SERIES OF 2022 OR AN ORDER PROVIDING FOR THE TEMPORARY CLOSURE OF D. FANDIÑO ST., J.P. RIZAL ST., MEDINA ST., JUAN LUNA ST., MALVAR ST., AND BAYLON ST., DURING THE CORAMBLAN FESTIVAL ON OCTOBER 6-12, 2022

WHEREAS, Section 21(c) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991," states that any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and waterworks projects, the duration of which shall be specified by the local chief executive concerned in a written order.

WHEREAS, endorsed to this Sanggunian is the letter from the Honorable Mayor for the temporary closure of D. Fandiño St., J.P. Rizal St., Medina St., Juan Luna St., Malvar St., and Baylon St., during the celebration of the CORAMBLAN Festival on October 6, 2022 to October 12, 2022;

WHEREAS, pursuant to Section 3(e) of Municipal Ordinance No. 8 series of 2019 otherwise known as "*An Ordinance Instituting the Procedure in connection with the Temporary Closure of Public Roads, Streets, Alleys, Parks, and Plaza for Fiesta Celebrations, Licensing and Permit Requirements for Temporary Peryantes or Vendors and Amusement Ride Operators, the Enforcement of the Ban Against Games of Chance with Monetary Rewards and Prescribing*

Penalties Therefor", the approval/confirmation of the EO shall be given by the SB through an appropriate resolution only after the favorable results of the required public consultations with residents of affected barangays such as but not limited to Barangay 1, Barangay 2, and Barangay 3 is secured;

WHEREAS, after deliberation and consultation with Barangay 1, Barangay 2, and Barangay 3 representatives and with concurrence of the majority of the Sanggunian, the Body decided to approve/confirm Executive Order No. 21 series of 2022, passage of which being in accordance with law;


