A RESOLUTION APPROVING THE LOCAL COUNCIL FOR THE CHILDREN/PERSON WITH DISABILITY PLAN OF ALAMINOS, LAGUNA AND UTILIZATION OF ONE PERCENT (1%) OF INTERNAL REVENUE ALLOTMENT FOR THE BUDGET YEAR 2023 AMOUNTING TO ONE MILLION SEVEN HUNDRED FIFTY FIVE THOUSAND TWO HUNDRED (1,755,200.00) PESOS.
