FLORES, MUNICIPAL MAYOR OF ALAMINOS, LAGUNA TO SIGN FOR AND BEHALF OF THE MUNICIPAL GOVERNMENT OF ALAMINOS, LAGUNA THE MEMORANDUM OF AGREEMENT (MOA) WITH EARLY CHILDHOOD CARE AND DEVELOPMENT COUNCIL (ECCDEC) REPRESENTED BY DRA. TERESITA G. INCIONG, EXECUTIVE DIRECTOR REGARDING THE ESTABLISHMENT OF A NATIONAL CHILD DEVELOPMENT CENTER (NCDC)”.

WHEREAS, the ECCDC is duly mandated in accordance with Republic Act 10410 (Early Years Act) to institutionalize a National System for Early Childhood Care and Development (ECCD) that is comprehensive, integrative and sustainable that will involve multi-sectoral and interagency collaboration at the national and local levels to promote the optimum growth and development of Filipino children ages (0) to four (4) years;

WHEREAS, in pursuance of the above mandate, the ECCDC aims to further enhance the provision of quality Home-Based and Center-based ECCD programs in partnership with stakeholders;

WHEREAS, the ECCDC intends to establish National Child Development Centers (NCDCs) including the provision of contents and teacher to serve as its laboratory of the different modes of delivery of center based ECCD programs;




