A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF SAN PABLO CITY, LAGUNA, MUNICIPALITY OF ALAMINOS, RIZAL, CALAUAN, LILIW, NAGCARLAN (SPARCLN), PROVINCIAL GOVERNMENT OF LAGUNA, THE LAGUNA PROVINCIAL HEALTH OFFICE OF LAGUNA, LAGUNA PROVINCIAL HOSPITAL- SAN PABLO DISTRICT HOSPITAL, SAN PABLO CITY GENERAL HOSPITAL AND THE DEPARTMENT OF HEALTH RO IV- A CALABARZON AND AUTHORIZING THE HON. MUNICIPAL MAYOR, GLENN P. FLORES TO SIGN INTO THE SAID MEMORANDUM OF AGREEMENT.

WHEREAS, Article X, Section 13 of the Philippine Constitution states: " Local Governments may group themselves, consolidate or coordinate their efforts, services and resources for purposes commonly beneficial to them in accordance with the law;

WHEREAS, Republic Act 7160, known as the 1991 local government code, mandated the devolution of health services as one of the primary functions and responsibilities of all local government units at all levels;

WHEREAS, Republic Act 11223 known as the Universal Health Act ensures fostering of a whole-of-system. A whole government and a whole-of-society approach in the development, implementation, monitoring and evaluation of health policies, programs and plans;

WHEREAS, Executive Order 205 of the Office of the President with the title " creation of national health planning committee and the establishment of inter-local health zones throughout the country;

WHEREAS, all parties agree that the resultant consolidation or Inter Local Health Zone would not be a new political subdivision that will have the same power and features as local government;

WHEREAS, The Municipal Government Units, Provincial LGU of Laguna, the PHO, the LPH-SPCGH, NDH and the DOH RO IV-A (Calabarzon) have signified their willingness to cooperate and pool their human, technical, financial, materials, and other essential resources;


WHEREAS, all parties agree that the cooperation will be called the “ SPARCLN (San Pablo, Alaminos, Rizal, Calauan, Liliw, Nagcarlan) Primary Care Providers Network) PCPN”, hereinafter referred to as “ SPARCLN PCPN”,

WHEREAS, the contracting members of the cooperating LGUs shall agree among themselves the mechanism and management with regards to the amount and frequency of contributions to a common SPARCLN PCPN health fund;


NOW,, THEREFORE, upon motion of Coun. Janis Angela Ilagan and duly seconded by Hon. Jeyson C. Abu and Approved by All Members of the Body Present **RESOLVED** as it is hereby resolved to ratify the Memorandum of Agreement between the City Government of San Pablo, Municipality of Alaminos, Rizal, Calauan, Liliw, Nagcarlan(SPARCLN), Provincial of Laguna, the Laguna Provincial Health Office Laguna , Laguna Provincial Hospital-San Pablo District Hospital, San Pablo City General Hospital, and Department of Health Regional Office IV-A Calabarzon and authorizing the Municipal Mayor Hon. Glenn P. Flores to sign and enter into Memorandum of Agreement of Inter Local Health Zone be ratified.
