A RESOLUTION APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) CY FOR THE YEAR 2023 OF ALAMINOS, LAGUNA ANNEX("A") AMOUNTING OF THREE HUNDRED SIXTY ONE MILLION TWO HUNDRED EIGHTY NINE THOUSAND NINE HUNDRED THIRTY (P361,289,930.00) PESOS.

WHEREAS, Section 410 of the IRR of R.A. No.7160 known as the Local Government Code of 1991 mandates the preparation and approval of Revised Annual Investment Program (AIP) during the fiscal Year before the calendar for budget preparation;

WHEREAS, the AIP is the yearly program expenditures both for capital and current operating requirement of the Local Government Unit that will serve as basis for the preparation of Annual And Supplemental Budgets;

WHEREAS, the Local Development Council submitted to the Local Finance Committee the AIP for the Fiscal Year 2023 amounting Three Hundred Sixty one Million Two Hundred Eighty Nine Thousand Nine Hundred Thirty (P 361.289,930.00) pesos and incorporated herein and made integral part of this resolution;

WHEREAS, R.A. 7160 mandates each and every Local Government Units (LGU) to appropriate at least 20% of the National Tax Allotment for development projects consistent with the principles and devolution and local autonomy;

WHEREAS, Section 21 of R.A 10121 mandates each LGU to appropriate of not less than Five percent (5%) of the estimated revenue from regular sources to support disaster risk reduction and management activities such as, but not limited to, pre-disaster preparedness programs and as quick response fund (QRP) or stand- by fund for relief and recovery programs;

WHEREAS, the Honorable Mayor who is the chairman of the MDC informed the Members that is really imperative for every Local Government Unit to adopt the Annual Investment Plan (AIP) for calendar year 2023 as an integral plan for the Budget Year 2023 of the Municipality of Alaminos, Laguna;

WHEREAS, the said AIP needs the ratification of the Sangguniang Bayan;

NOW, THEREFORE, upon motion of Hon. Nicole A. Pampolina and unanimously approved by All Members of the Body Present RESOLVED as it is Herby RESOLVED the said Annual Investment Program for the Fiscal Year 2023 be approved and ratified;

RESOLVED FURTHER, that copies of this Resolution be furnished the Municipal Treasurer, Budget Officer and Accounting Officer, Alaminos, Laguna for their information.
