**A RESOLUTION REQUESTING THE SAN MIGUEL CORPORATION, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, TOLL REGULATORY BOARD, AND ALL OTHER CONCERNED AGENCIES TO CONSTRUCT THE SOUTH LUZON EXPRESSWAY TOLL ROAD 4 (TR-4) EXIT IN ALAMINOS, LAGUNA.**

**WHEREAS**, The Municipality of Alaminos is surrounded by the cities of San Pablo, Sto. Tomas, and Lipa, making Alaminos a center and catch basin of heavy traffic in the area;


**WHEREAS**, said construction shall further improve the transport of goods and services from Alaminos to Manila and vice versa;


